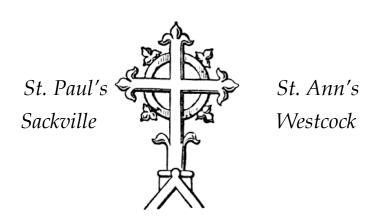

Parish of Sackville Annual Meeting St. Paul's, Sackville, NB Sunday, February 28, 2021

Annual Report for 2021 Pre-Lent, 2022

This second past full year of the global pandemic has perhaps been more trying the first. All the stopping and starting; the isolation and disruption has wreaked havoc on the settled rhythm of our lives more than we can even assess in the short term. Any sure prediction of the near future has so often proved to be wrong footed and outdated, almost as soon as its spoken let alone written down. So we forecast the future- this coming year- on the basis of what we've known certainly in the past.

Our churches have remained open for worship. It's been said that one of the chief emblems of Anglicanism is the parish church in each village, town and district. In Westcock, Sackville and Dorchester(the only one left standing for this purpose there), our churches stand on hillside and bend in the main street, pointing to heaven; symbols in wood and glass and stone, of the out-flowing of the divine life, and the everlasting love of our heavenly Father. We're grateful for the humble and wise policy of Archbishop Edwards that, in distinction from neighbouring dioceses, we've been allowed through pandemic restriction after restriction, to more or less safely remain open as we have for generations, to proclaim and hear the Word of God, to consecrate the holy mysteries, to baptize and bury. As one Bishop has written, the church building, our church buildings stand for the dependability of God, and for God's power and presence as located, permanent and enduring...literally transcending the human world with its transitoriness and fallibilities. I am so grateful for the care, sacrifice and faithfulness of all of you for turning the matter of monies, time and work to the praise of God, and that in turn for our spiritual food in Word and Sacrament Sunday by Sunday and day by day, in the upkeep of our churches. We look forward in what we hope is the very near future, to continuing this service to our whole communities, first in spiritual services, and then in its accessories- hospitality through activities as coffee in the woods, community building fundraisers, pancake & parish suppers, study and fellowship, the continued outreach of the Christmas Cheer programme; the 2022 Atlantic Theological Conference, June 26-28 at S. Ann's and S. Paul's. Whatever the ingenuity of live-streaming worship and the wonderful up keeping of Zoom Sunday school by Mari and all the others who have so generously and joyfully contributed to this; for Christians the virtual and potential can never replace the personal, embodied, assembled gathering of the faithful for fellowship and worship n person, the audible hearing of Faith, and the spiritual sharing of the physical Sacraments.

We've all learned through frustration and sadness over the past couple of years, that physical distancing and separation hurts, as a kind of faint foretaste of death. And we have bid farewell to several beloved of our membership through the gateway of death to eternal life; and some through moves away or other arrangements. We don't forget about each other, but rather adhere to the *ties that bind* us in living faith, hope, love and prayer in the Lord Jesus, Head of our Body, one with another, in the mystery of the Church. *And* we continue to welcome others in. The state of the Christian is never alone, individual, but as a member of the body into which we are baptized. We've had several families join or re-join us-for what we've continued to do, and how we do it-even in the midst of the pandemic. At the time of writing adult candidates are being prepared for baptism and confirmation, couples for holy matrimony; others are making first

confessions; others still are returning to the sacraments after many years apart from them. A full & welcoming church, one where members notice newcomers & take the time to warmly welcome and greet them, is a crucial part of the ministry of each one of us.

Finally, one important and developing aspect of our life together in the coming year, will be to try to better share our mutual responsibility before God and one another, in increased committee work, to pool our talents so that not too much information or work lies at the feet of one person. We can endeavour to do this in everything from our finances, to building maintenance and hall bookings; to fundraising & special event planning. If you feel so moved to offer your time and talent to any of these collaborative activities, please don't hesitate to let us know!

I give thanks to God for all of you, for all you continue to teach me; and look forward in faith to serving with you in what I pray is a better 2022!
